The Program:

This program will:

1. Increase the environmental knowledge of planners, landscape architects, engineers, and developers throughout the state.
2. Encourage development professionals to adopt habitat conservation, preservation, or enhancement practices.
3. Increase the amount of environmental habitat that is preserved and/or enhanced during human development projects.

The program will consist of two weekend workshops with each weekend comprising two eight-hour days for a total of 32 hours of environmental training. A final examination will be required for certification. Workshop participants will be exposed to readings, lectures, discussions, and activities to facilitate critical-thinking and enhance comprehension of fundamental environmental concepts. All training materials will be approved by a board of professionals to ensure an appropriate quality of content.



Training Benefits:

1. Upon successful completion of the program, participants will receive a certification from the Indiana Wildlife Federation recognizing their accomplishment.
2. Each participant will receive an Environmental Habitat Steward Training Book containing all of the materials used during the training as well as information regarding additional resources that may be available.
3. Each participant will gain valuable knowledge that will let them take advantage of programs such as the Sustainable Sites Initiative and U.S. Green Building Council's LEED program.
4. Each participant will be able to meet and network with a variety of environmental professionals.
5. Participants will gain knowledge of IWF's Wildlife Friendly Certification Program which provides assistance and recognition for sustainable development projects.
6. This extensive training opportunity will be offered at a discounted price of \$50 per registrant.

Post-training Benefits:

1. IWF will publicly recognize companies and organizations that staff Environmental Habitat Stewards. An up-to-date list of these companies, their services, and periodic "Featured Projects" will be advertised through IWF workshops, our website, IWF's *Hoosier Conservation* magazine, and various other public events.
