Cleanups, Beautification and Placemaking: Through the Cleanups, Beautification and Placemaking programs, there were 366 neighborhood clean-ups, 857 blocks were adopted by neighborhood leaders, 5 Greenspaces were added as neighborhood amenities and 14 Greenspaces were maintained and volunteers were trained to manage the spaces in the future. Through these programs 2,157,553 lbs. of trash were picked up and 15,479 volunteers were engaged to assist with these projects.

4b (Code:) (Expenses \$ **517,123** including grants of\$) (Revenue \$ **316,240**)

Community Forestry: Through the Community Forestry program, 2,659 trees were planted in neighborhoods around central Indiana. These trees will increase the tree cover in areas that were significantly lacking, reduce crime by creating more sociable neighborhoods, improve the air and water quality, and increase property values. 2,502 volunteers assisted with this program.

Youth Programming: Through KIB's KIB Clubs and Youth Tree Team, 2,690 students were engaged in learning about and improving their environment. KIB Clubs included programs at 5 schools where students, teachers and parents were engaged in creating and maintaining outdoor classrooms, planting trees, and developing recycling programs for their school. KIB's Youth Tree Team maintained over 6,000 trees, as well as participated in enrichment activities such as learning financial management skills and networking with green-collar professionals.

Extensions of Time to File

The Department recognizes the Internal Revenue Service application for automatic extension of time to file, Form 8868. **Please forward a copy of your federal extension, identified with your Nonprofit Taxpayer Identification Number (TID), to the Indiana Department of Revenue, Tax Administration by the original due date to prevent cancellation of your sales tax exemption.** Always indicate your Indiana Taxpayer Identification number on your request for an extension of time to file.

Reports post marked within thirty (30) days after the federal extension due date, as requested on Federal Form 8868, will be considered as timely filed. A copy of the federal extension must also be attached to the Indiana report. In the event that a federal extension is not needed, a taxpayer may request in writing an Indiana extension of time to file from the: Indiana Department of Revenue, Tax Administration, P.O. Box 6481, Indianapolis, IN 46206-6481, (317) 232-0129.

If Form NP-20 or extension is not timely filed, the taxpayer will be notified by the Department pursuant to I.C. 6-2.5-5-21(d), to file Form NP-20. If within sixty (60) days after receiving such notice the taxpayer does not file Form NP-20, the taxpayer's exemption from sales tax will be canceled.
