Cleanups, Beautification, and Placemaking: More than 11,500 volunteers joined KIB in cleaning and revitalizing neighborhoods in 2017. KIB coordinated 339 neighborhood cleanups to combat heavy litter, and more than 1,100 neighborhood leaders adopted their blocks to keep them clean on an ongoing basis, using free supplies and resources from KIB. Together, people removed more than 912.5 tons of litter from Indianapolis streets, alleys, greenspaces, and waterways. KIB's GreenSpace program, which is committed to creating vibrant places and communities, transformed vacant lots and underused spaces into natural, beautiful, and functional pocket parks. KIB created three greenspaces in 2017 and helped project partners maintain 14 greenspaces created in past years.

4b (Code:) (Expenses \$ **1,047,846** including grants of\$) (Revenue \$ **559,601**)
Community Forestry: In 2017, KIB planted 3,005 trees in strategic locations throughout Marion County, surpassing a total of 50,000 total trees planted by KIB since 2006. KIB's customized mapping tool helped staff identify where trees might provide the most community, health, and environmental benefits, helping KIB decide where to direct outreach and community engagement efforts; many of these trees will help capture stormwater, preventing sewage from overflowing into Indy streams during heavy rains. Over 90% of the trees were native to Indiana and surrounding states, with 979 of the trees planted classified as "giving trees" (trees that support 200 or more species of moths and butterflies). Nearly 2,800 volunteers assisted with the plantings, adding trees to neighborhood streets, schools,

Youth Programming: KIB's youth programs, GreenKids (formerly KIB Clubs) and the Youth Tree Team (YTT), engaged over 1,000 students in learning about and improving their environment. The 85 teens and college students in YTT played a vital role in ensuring the survival of KIB's trees the first three years after planting. YTT watered 3,135 trees weekly and pruned 1,758 trees, meaning the youth were responsible for watering nearly half and pruning about a third of the young trees in KIB's care in 2017. The youth earned work skills certificates and participated in enrichment activities, such as learning financial management, visiting tree nurseries, camping, and going on college tours. Through KIB GreenKids, five elementary schools created after-school, nature-focused clubs where 3rd through 5th graders
